

ADVERTISEMENT FOR BIDS

FRUITDALE ROAD AND McGARIGLE ROAD IMPROVEMENTS AND SR 9 PEDESTRIAN/BICYCLE SAFETY IMPROVEMENTS PROJECT

Sealed bid proposals will be received by the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley, Washington, 98284 until **2:00 p.m., May 1, 2009** at which time the bids will be opened and publicly read.

This Contract provides for installation of storm drainage utilities, roadway reconstruction and pedestrian improvements, and intersection improvements on McGarigle Road between SR 9 and Fruitdale Road, and on Fruitdale Road between SR 20 and McGarigle Road. The project also includes widening approximately 2500 feet of the west side of SR 9 between SR 20 and Lucas Drive.

Work in the project includes: sawcutting and removal of asphalt pavements and concrete, removal of existing storm drain system, furnishing and installing new storm drainage facilities including conveyance and detention, construction of detention pond, installing sanitary sewer manholes and main and service stubs, installation of pre-engineered storm sewer pump station and forcemain, installation of sanitary sewer pump station and forcemain, sewer pump station generator and control building installation of roadway embankment and excavations, hot mix asphalt roadway and pathway paving, installation of concrete curb, gutter, sidewalks, ramps, and gravity block retaining walls, installation of pavement markings, traffic signs, fence replacement, traffic control, erosion control, wetland mitigation area grading and other work.

All work shall be done in accordance with the Special Provisions of the Bid Documents, the 2008 Standard Specifications for Road, Bridge, and Municipal Construction, including the amendments thereto.

All bid proposals shall be accompanied by a bid pro, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful bidder fail to enter into such contract within the time stated in the specifications, the bid proposal deposit shall be forfeited to the City of Sedro-Woolley.

Bid documents may be reviewed and purchased at the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley. A non-refundable fee of **\$65** will be charged for each set of bid documents (includes shipping). A pre-bid meeting scheduled for **April 21, 2009, at 10:00 a.m.** will be held for all prospective bidders. The pre-bid meeting will begin at the City of Sedro-Woolley City Hall Council Chambers, 325 Metcalf Street, Sedro-Woolley, Washington and will include a walk through at the project site.

The following is applicable to Federal aid projects.
