



## INVITATION TO BID

### 2015 Fencing Project

The City of Sedro-Woolley is soliciting bids under the city's Small Works Roster process utilizing MRSC Rosters for the 2015 Fencing Project. The work will generally consist of Type 3 and Type 4 chain link fencing and miscellaneous fencing repairs, as detailed on the Bid Proposal Form and Attachments A through E. The estimated value of the work is under \$35,000.

Materials provided for individual projects will be per City of Sedro-Woolley Public Works Department Standards. Construction will be performed per the current edition of the Standard Specifications for Road, Bridge and Municipal Construction and City standards. See the attached Public Works Agreement for insurance, bonding, prevailing wage provisions and other provisions applicable to this contract. State prevailing wage rates per Washington State Department of Labor and Industries are required. Contractors must be registered contractors at time of bid, have a current UBI number, have industrial insurance coverage as verified by WA L&I, have an Employment Security Department number, have a WA state Excise Tax Registration Number, and must not be disqualified from bidding per the Debarred Contractors list. Successful bidder must have or shall obtain a Sedro-Woolley business license. Bidder shall register or maintain registration on our MRSC Small Works Roster prior to award.

**Proposals are due by 2 pm on Thursday, March 26, 2015.** A formal bid opening will not be held. Results of the bid will be posted on the city website after award.

Interested contractors shall submit the completed Bid Proposal Form utilizing the form provided, a Statement of Bidder's Qualifications including references utilizing the form provided, and the Contractor's current rate sheet including labor and equipment rates, mark-up rate for materials.

All work is to be completed within **30 working days** of the Notice to Proceed.

Basis for selection will be lowest responsible bid as determined by a comparison of Bid Proposals received, a review of qualifications and references, and capacity to respond within the time frame stated.

The City of Sedro-Woolley reserves the right, without any liability on our part, to accept a proposal of the bidder submitting the lowest responsible bid, to reject any or all bids, revise or cancel the work to be performed, or do the work otherwise, if the best interest of the City is served thereby.
