



## REQUEST FOR PROPOSALS

### Memorial Park Caretaker Residence Drywall Project

The City of Sedro-Woolley is soliciting bids through our small works roster process for the installation of drywall in a 1176 square foot new construction residential structure located at 695 Pacific Street, Sedro-Woolley Washington.

Instructions to Bidders: The building in question is a slab on grade, concrete block constructed building with wooden trusses. The building was originally constructed as a picnic shelter in 2007. The building is being converted into a 2 bedroom, 1 bath residential structure to be used as a park caretaker residence. Interior 2' X 6' stem walls have been added for plumbing, electrical, insulation and drywall.

Job will consist of the installation of drywall sheets, and all mudding taping, priming, and eggshell texturing.

A floorplan sketch of the building is available.

Proposals shall include total costs including labor and materials, obtaining necessary licenses and permits (local and/or state), and all equipment necessary to safely complete the job, disposal of all related waste, and cleanup of the site.

Materials provided for this project will be per the current edition of the International Building Code, or equal to existing materials as appropriate. Work will be performed per the current edition of the International Building Code and City standards. See the attached Public Works Agreement for insurance, bonding, prevailing wage provisions and other provisions applicable to this contract. State prevailing wage rates per Washington State Department of Labor and Industries are required. For current rates in Skagit County use the following link:

Contractors must be registered contractors at time of bid, have a current UBI number, have industrial insurance coverage as verified by WA L&I, have an Employment Security Department number, have a WA state Excise Tax Registration Number, and must not be disqualified from bidding per the Debarred Contractors list. Successful bidder must have or shall obtain a Sedro-Woolley business license. Bidder shall register or maintain registration on our MRSC Small Works Roster Prior to award.

Proposals are due by 2 pm on **Thursday, January 28, 2016**. Interested contractors are to provide a lump sum Proposal and a Statement of Bidder's Qualifications including references utilizing the forms provided.
