



## ADVERTISEMENT FOR BIDS

### **SR 20/Cascade Trail West Extension Phase 1A Trail Road to SR 9 South & Phase 1B Hodgins Road to Trail Road**

Sealed bid proposals will be received by the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley, Washington, 98284 until **2:00 p.m., Thursday, March 23, 2017**, at which time the bids will be opened and publicly read.

The work to be performed under this contract consists of sidewalk construction (approximately 2,900 LF) and storm drain improvements (approximately 2,000 LF) along the north side of SR 20 between Hodgins Road and SR 9 South. Work consists of saw cutting, pavement and concrete removal, tree removal, widening existing sidewalks, installing new 10-ft wide sidewalks and sidewalk ramps, installing concrete traffic curb and gutter, removing existing drainage structures and pipes, installing new storm structures and pipes, traffic control, erosion control, pavement marking, mailbox relocation, removing parking lot light standards, and signs.

Bid documents may be reviewed and purchased at the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley, WA. A non-refundable fee of **\$60** will be charged for each set of bid documents (add \$20 for shipping). Checks should be made payable to the City of Sedro-Woolley and mailed to the Public Works Department, 325 Metcalf Street, Sedro-Woolley, WA 98284. All work shall be done in accordance with the Special Provisions of the Bid Documents, the 2016 WSDOT Standard Specifications for Road, Bridge, and Municipal Construction, including the amendments thereto, City Standards and other referenced documents.

All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful bidder fail to enter into such contract within the time stated in the specifications, the bid proposal deposit shall be forfeited to the City of Sedro-Woolley.

A non-mandatory pre-bid meeting is scheduled for **Tuesday, March 7, 2017, at 10:00 a.m.** and will be held for all prospective bidders. The pre-bid meeting will begin at the City of Sedro-Woolley City Hall Municipal Training Room, 325 Metcalf Street, Sedro-Woolley, Washington and will include a walk through at the project site.

The City of Sedro-Woolley, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of

Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-Assisted Programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises as defined at 49 CFR Part 26 will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.

The City of Sedro-Woolley reserves the right to accept a proposal of the bidder submitting the lowest responsible bid, to reject any or all bids, revise or cancel the work to be performed, or do the work otherwise, if the best interest of the City is served thereby. The City of Sedro-Woolley also reserves the right to postpone the bid award for a period of thirty (30) calendar days after bid opening.
