



## **REQUEST FOR PROPOSALS 2018 ARTERIAL STREET CRACK SEAL PROJECT**

The City of Sedro-Woolley is soliciting bids through the small works roster process for crack sealing on 11 different city streets. The selected contractor shall provide labor, equipment and materials to perform the work as described below:

### **Instructions to Bidders:**

The contractor shall clean all Transverse, Reflective and Longitudinal cracks greater than 1/8" – inch in width with the Hot Compressed Air Lance method. Cracks greater than 1/4" shall also be cleaned prior to hot compressed air cleaning with a mechanical wire brush. Cracks shall be completely filled in with hot applied joint sealant asphalt emulsion crack seal. "Crack Sealing" and "Crack Sealing with Routing" shall be performed in accordance with FHWA Technical briefing "Sealing and Filing Cracks in Asphalt Pavements," current edition. Crack Seal treatment material to be "Crafco Road Saver 534 Low Tack" or City approved equal. Total length of cracks to be cleaned and sealed is approximately 60,000 LF. Contractor shall be responsible for furnishing all traffic control. Traffic control plans to be approved by the City Engineer. City will assist with public notification on the affected streets, and will coordinate having vehicles removed from streets prior to the beginning of work.

**\*Engineers estimate for this project is \$90,000 to \$100,000**

1. West State Street from Rita Street to Maple St
2. Metcalf Street from Northern Ave to SR 20
3. Township Street from Ferry Street to Sterling St
4. East State Street from Township Street to 1200 Block
5.
  - a. North Reed Street from SR20 to Sapp Rd
  - b. Sapp Road from Brickyard Blvd to North Reed St
  - c. Longtime Lane full length
  - d. Brickyard Boulevard full length
  - e. Creek Lane full length
  - f. Brick Lane full length
6. Ferry Street from BNSF at SR20 to Eastern Street

Proposals shall include mobilization and demobilization, traffic control plans, traffic control, clean up and disposal of materials removed from cracks, labor, equipment and materials, sales tax, freight, all licenses, permits, fees etc. not otherwise specifically mentioned to safely complete the job.

Materials and Construction provided for this project will be per City of Sedro-Woolley Public Works Department Standards and the current edition of the Standard Specifications for Road, Bridge and Municipal Construction.

Contractors must be registered contractors at time of bid, have a current UBI number, have industrial insurance coverage as verified by WA L&I, have an Employment Security Department number, have a WA state Excise Tax Registration Number, and must not be disqualified from bidding per the Debarred Contractors list. Successful bidder must have or shall obtain a Sedro-Woolley business license.

Bidder shall register or maintain registration on our small works roster hosted by MRSC Rosters at <http://www.mrscrosters.org> prior to award.

Proposals are due by **2 pm on Tuesday, March 27, 2018**.
