



INVITATION TO BID

2018 ON-CALL ASPHALT PAVEMENT SERVICES

The City of Sedro-Woolley is soliciting bids under the city's Small Works Roster process utilizing MRSC Rosters for our 2018 On-Call Asphalt Pavement Services.

BACKGROUND: At various times throughout the construction season the Public Works Operations Division has the need for paving services to assist with city projects. The city has the need for these services on an average of 4 working days per year. Work hours are for an 8 or 10 hour shift between the hours of 6:30 am and 4:30pm. Projects shall be scheduled between the contractor representative and the city Public Works Operations Division Manager.

PROJECT SCOPE: For the typical project, the city provides the asphalt, dump trucks, roller compactor, tack truck, and traffic control. The contractor shall be responsible for providing an operated self-powered asphalt paving machine able to pave from 8' to 15'. For larger projects, the city may require an additional 12/14 CY dump truck provided by the contractor. Estimated value of this contract for 2018 is between \$15,000 and \$25,000 dollars. This is only an estimate and this level of work is not guaranteed.

BASIS FOR BIDS: Bid comparison and award will be based on a typical one-day project installing an estimated 500 tons of asphalt to be completed in 10 hours. Bids shall include an hourly rate for asphalt paver rental including operators, plus mobilization and demobilization. Rates shall be effective once the contractor arrives at the job site.

Proposals shall include total costs including freight, labor and materials, obtaining necessary licenses and permits (local and/or state), and all equipment necessary to safely complete the job, disposal of all related waste and cleanup of the site.

Materials and Construction provided for this project will be per City of Sedro-Woolley Public Works Department Standards and the current edition of the Standard Specifications for Road, Bridge and Municipal Construction.

Contractors must be registered contractors at time of bid, have a current UBI number, have industrial insurance coverage as verified by WA L&I, have an Employment Security Department number, have a WA state Excise Tax Registration Number, and must not be disqualified from bidding per the Debarred Contractors list. Successful bidder must have or shall obtain a Sedro-Woolley business license.

Bidder shall register or maintain registration on our MRSC Rosters Small Works Roster at <http://www.mrscrosters.org> prior to award.

Proposals are due by **2 pm on Thursday, April 26, 2018**. - Statement of Bidder's Qualifications (including references utilizing the forms provided)
- Certification of Compliance with Wage Payment Statutes – submit completed form within 24 hours of bid
