**Environmental Review:** The optional DNS process in WAC 197-11-355 is being used. Agencies, tribes, and the public are encouraged to review and comment on the proposed project and its probable environmental impacts. - 4. Any water discharged to the City stormwater system as a result of this project must be approved by and comply with conditions of the Public Works Department;
- 5. Provide a temporary erosion and sedimentation control plan for approval by the city engineer; and
- 6. All construction traffic shall use temporary construction access as approved by the Public Works Department.
