



ADVERTISEMENT FOR BIDS

2018 STATE STREET PAVEMENT AND UTILITY IMPROVEMENTS PROJECT

Sealed bid proposals will be received by the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley, Washington, 98284 until **2:00 p.m., August 2, 2018**, at which time the bids will be opened and publicly read.

This contract provides for asphalt pavement overlays, as well as pedestrian improvements on West State Street and State Street within the City of Sedro-Woolley. Overlay work consists of 2-inch HMA overlay on West State Street between the BNSF tracks near SR 20 and Maple Street (approx. 2,550 SY), on State Street between Rita Street and Metcalf Street (approx. 3,520 SY) and State Street between Third Street and Puget Street (approx. 2,170 SY). Overlay work will include planing, repairs to sections of roadway, and pavement markings. Pedestrian improvements include the removal and replacement of existing sidewalk and ramps as well as constructing new ramps (19 total). Utility improvements include the installation of 12" and 8" ductile iron water mains and appurtenances (approx. 1220 LF), service renewals and hydrant installation. Other work elements include traffic control, adjusting existing structures, sign relocation and misc. paving.

Bid documents may be reviewed and purchased at the City of Sedro-Woolley Public Works Department, 325 Metcalf Street, Sedro-Woolley. A non-refundable fee of **\$40** will be charged for each set of bid documents (add \$20 for shipping). Checks should be made payable to the City of Sedro-Woolley and mailed to the Public Works Department, 325 Metcalf Street, Sedro-Woolley, WA 98284. The Bid Documents and addenda are also available on-line at www.ci.sedro-woolley.wa.us/resources/bids_and_awards/index.php. Contractors who download these Bid Documents are responsible for insuring that they are added to the plan holder's list in order to receive any issued addenda. All work shall be done in accordance with the Special Provisions of the Bid Documents, the 2018 WSDOT Standard Specifications for Road, Bridge, and Municipal Construction, including the amendments thereto, City Standards and other referenced documents.

All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check, or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should the successful bidder fail to enter into such contract within the time stated in the specifications, the bid proposal deposit shall be forfeited to the City of Sedro-Woolley.

A non-mandatory pre-bid meeting is scheduled **July, 24, 2018, at 2:00 p.m.** and will be held for all prospective bidders. The pre-bid meeting will begin at the City of Sedro-Woolley City Hall Training Room, 325 Metcalf Street, Sedro-Woolley, Washington and will include a walk through at the project site.

The City of Sedro-Woolley, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-Assisted Programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises as defined at 49 CFR Part 26 will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, national origin, or sex in consideration for an award.

The City of Sedro-Woolley reserves the right to accept a proposal of the bidder submitting the lowest responsible bid, to reject any or all bids, revise or cancel the work to be performed, or do the work otherwise, if the best interest of the City is served thereby. The City of Sedro-Woolley also reserves the right to postpone the bid award for a period of thirty (30) calendar days after bid opening.
