REQUEST FOR QUALIFICATIONS
PROFESSIONAL SERVICES SOLICITATION

The City of Sedro-Woolley solicits interest from consulting firms with expertise in Civil Engineering Design. The agreement is for approximately September 2019 through February 2020 with the option for the City to extend it for additional time and money if necessary. Consultants will be considered for the following project.

The City reserves the right to amend terms of this “Request for Qualifications” (RFQ) to circulate various addenda, or to withdraw the RFQ at any time, regardless of how much time and effort consultants have spent on their responses.

The work performed by the Consultant consists of preparing preliminary engineering design for the **City of Sedro-Woolley SR20-SR9/Township Intersection Improvements Project (STPUS-0020(199))**. The existing signalized intersection has a dedicated left turn lane on the west leg only, with combined through and left turn legs at the other three legs. Daily traffic volumes entering the intersection exceed 19,000 vehicles. The proposed improvements consists of intersection channelization improvements to allow concurrent north-south left turn lanes and improve signal sequencing, including signal modifications, drainage, HMA pavement, curbing and sidewalk/path improvements. Design work to include topographic survey, geotechnical evaluation, environmental documentation, preparation of permit applications, determination of right of way needs and right of way plan preparation (if needed), channelization plan for WSDOT approval, and signal modification design. Design Phase work is scheduled to start in September 2019, with completion no later than February 2020.

The City reserves the right to retain the services of the successful firm for any subsequent phases (R/W, CN) associated with this project.

The Underutilized Disadvantaged Business Enterprise (UDBE) goal for professional services contracts for this project is zero percent. Voluntary SBE Goal of ten percent (10%) of the Agreement is established. The consultant shall submit a SBE Participation Plan prior to commencing work on the Agreement.
