

INVITATION FOR BIDS 2021 Memorial Park Tree Removal Project & Unit Priced Services

The City of Sedro-Woolley is soliciting bids under the city's small works roster process utilizing MRSC Rosters and the Limited Public Works process for the removal of 5 evergreen trees located at Memorial Park, 703 Pacific Street, Sedro-Woolley, WA. Additionally, this contract will allow the city to utilize the services of the contract on an on-call, as needed basis for the 2021 calendar year.

Instructions to Bidders:

Schedule 1 of the job will consist of safely cutting down 5 (five) trees, chipping all limbs, disposing of the wood and grinding the stumps at least 6" below finished grade.

The Lump Sum Bid for Schedule 1 shall include total costs including labor and materials, obtaining necessary licenses and permits (local and/or state), and all equipment necessary to safely complete the job, disposal of all related waste, and cleanup of the site.

Schedule 2 allows for tree trimming or removal on a unit price (hourly) basis. Schedule 2 will consist of a hypothetical one-day tree removal job. Equipment will be paid based on the requirements of the individual project.

Basis for selection will be lowest responsible bid as determined by a comparison of Bid Proposals received and a review of qualifications and references,

Bids shall include total costs including obtaining necessary licenses and permits (local and/or state), mobilization, labor, tools and equipment necessary to safely complete the job, haul off of any waste and cleanup of the sites.

Materials and Construction provided for this project will be per City of Sedro-Woolley Public Works Department Standards and the current edition of the Standard Specifications for Road, Bridge and Municipal Construction.

State prevailing wage rates per Washington State Department of Labor and Industries are required. For current rates in Skagit County use the following link: https://secure.lni.wa.gov/wagelookup/ and use the bid close date as the effective date.

Bidder Responsibility Criteria: Bidders must be registered contractors at time of bid, have a current UBI number, have industrial insurance coverage as verified by WA Labor and Industries, have an Employment Security Department number, have a WA state Excise Tax Registration Number, and must not be disqualified from bidding per the Debarred Contractors list. If bidding on a public works project subject to the apprenticeship utilization requirements, must not have been found out of compliance by the WA State apprenticeship and training council for the one-year period immediately preceding the date of the bid solicitation. Bidders must have received training on the requirements related to public works and prevailing wage under RCW chapters

39.04.350 and 39.12. Bidders within the three-year period immediately preceding the date of the bid solicitation, may not have been determined by a final and binding citation and notice of assessment issued by the WA Labor and Industries or through a civil judgement entered by a court as defined in RCW 49.48.082 or any provision of chapters 49.46, 49.48, or 49.52 RCW.

Bidders shall register or maintain registration on MRSC Rosters at http://www.mrscrosters.org prior to bid opening. Successful bidders must have or shall obtain a Sedro-Woolley business license at https://dor.wa.gov/city-license-endorsements/sedro-woolley prior to any payment.

Bid proposals are due by **2 pm** on **January 28, 2020**. - Certification of Compliance with Wage Payment Statutes utilizing the form provided
- Must have received training related to the public works and prevailing wage requirement or be exempt as verified by WA Labor and Industries (RCW 39.04.350(f))
- Registered on the City of Sedro-Woolley's Small Works Roster utilizing MRSC Rosters
- Current Rate Sheet including labor and equipment rates may provide on company letterhead

The City of Sedro-Woolley reserves the right, without any liability on our part, to accept a proposal of the bidder submitting the lowest responsible bid, to reject any or all bids, revise or cancel the work to be performed, or do the work otherwise, if the best interest of the City is served thereby.
