



## INVITATION FOR BID

### 2021 State Street Pump Station Rehab Project

The City of Sedro-Woolley is soliciting bids under the City's Small Works Roster utilizing MRSC Rosters for upgrades to our State Street Pump Station located at 600 W. State Street, Sedro-Woolley, WA 98284

The project consists of removal and disposal of the existing submersible pumps, rails and discharge piping and the installation of new Grundfos Submersible Solids Handling Pumps Model SE1.30.A40.175.4.52H.C.EX.61R with 4-inch discharge and 17.5 HO 1750 RPM, 460V, 3 ph, 60 Hz Inverter duty, submersible motor. Pump specs 700 GMM @ 55' TDH to match existing pump head and flow. Also including a 4" Grundfos Auto Coupling Rail System, complete with base elbows, pump guide brackets and guide rail brackets, and 2-inch Sch. 40 304 stainless steel guide rail pipe and miscellaneous mounting hardware. Also including Grundfos Pump Monitor Relay and power and control cables (approximately 50-feet for each pump – contractor to verify actual length required). The city will consider equivalent systems to the specified pump system. Alternatives must be approved prior to bid submittal. The installation shall include all labor and equipment and incidentals to provide a complete system, including disconnection and reconnection of power service and control wiring at the existing hand-hole, explosion proof sealing, mobilization and demobilization and start up. Contractor is responsible for all required safety measures to safely perform the work, including confined space entry requirements. Standard manufactures warranty is required.

Details on the condition of the existing pump station equipment along with photos is provided in the PumpTech "Sedro-Woolley State Street Lift Station Report" dated 5/21/2020 included on the city website.

City forces will provide bypass pumping during the performance of the work. City will shut down and clean the pump station before start of work.

Contractor will schedule the work with the city and **complete the work within five consecutive working days.**

Work will be performed per the current edition of the International Building Code, National Electrical Code and City standards.

State prevailing wage rates per Washington State Department of Labor and Industries are required. For current rates in Skagit County use the following link: <https://secure.lni.wa.gov/wagelookup/> and use the bid close date as the effective date.

RCW 39.04.350 establishes bidder responsibility criteria. Before the City may accept a Contractor's bid, the contractor must:

- Be a registered contractor at time of bid submittal (RCW 18.27.020)
- Have a current state Unified Business Identifier (UBI) number

- Have industrial insurance coverage as verified by WA Labor and Industries (RCW Title 51)
- Have an Employment Security Department number (RCW Title 50)
- Have a state Excise Tax Registration number (RCW Title 82)
- Have never been disqualified from bidding under RCW 39.06.101 or 39.12.065(3)
- If bidding on a public works project subject to the apprenticeship utilization requirements in RCW 39.04.320, must not have been found out of compliance by the WA State apprenticeship and training council for the one-year period immediately preceding the date of the bid solicitation.
- Bidders must have received training on the requirements related to public works and prevailing wage under RCW chapters 39.04.350 and 39.12.
- Bidders within the three-year period immediately preceding the date of the bid solicitation, may not have been determined by a final and binding citation and notice of assessment issued by the WA Labor and Industries or through a civil judgement entered by a court as defined in RCW 49.48.082, any provision of 49.46, 49.48, or 49.52.

Bidders shall register or maintain registration on MRSC Rosters at <http://www.mrscrosters.org> prior to bid opening. Successful bidders must have or shall obtain a Sedro-Woolley business license at <https://dor.wa.gov/city-license-endorsements/sedro-woolley> prior to any payment and be current with all applicable licenses, taxes, and fees owed to the City of Sedro-Woolley.

Successful bidders will also be required to submit a copy of their COVID-19 safety plan prior to their start date.

Interested contractors are to submit, have completed, and registered **prior to bid opening**:

- **Bid Proposal Form** utilizing the form provided
- A **Statement of Bidder's Qualifications** including references utilizing the form provided
- **Certification of Compliance with Wage Payment Statutes** utilizing the form provided
- Must have received training related to the public works and prevailing wage requirement or be exempt as verified by WA Labor and Industries (RCW 39.04.350(f))
- Registered on the City of Sedro-Woolley's **Small Works Roster** utilizing MRSC Rosters

**Proposals are due by 2 pm on Thursday, May 6, 2021.** A formal bid opening will not be held. Basis for selection will consist of comparison of lump sum bid and a review of qualifications and references.
